## **Online Privacy Policy**

## Types of Information Collected and How It Is Used

F.I.S.H. gathers limited personal information, such as first and last names, home addresses, e-mail addresses and credit card numbers, only when voluntarily submitted by you. If you make an online donation or register for a special event, personal information will be collected from you in order to process that donation or register you for that event.

With your permission, we will use personal information collected from you to send information, such as F.I.S.H. updates or information regarding new programs, events or fundraising initiatives. If you do not wish to receive such materials, you will have the ability to opt out and we will no longer send updates to you.

## **Sharing of Personal Information**

Companies may be engaged by F.I.S.H. to perform a variety of functions, such as providing technical services for our Internet sites, etc. Such companies may have access to personal information if needed to perform certain functions; however, these companies may use such personal information only for the purpose of performing that function and may not use it for any other purpose. Other than as provided in this privacy policy, F.I.S.H. does not sell, transfer or disclose personal information to third parties.

F.I.S.H. reserves the right to use or disclose any information as needed to satisfy any law, regulation or legal request, to protect the integrity of the site, to fulfill your requests, or to cooperate in law enforcement investigation or an investigation on a public safety matter.

Donor information is stored within a donor management database maintained by F.I.S.H. Access to the database is restricted to F.I.S.H. staff with legitimate business needs to access or modify this information.
