Thank you for your interest in the FISH OF SANCAP Hurricane Preparedness Program. As we learned from Hurricane Ian, storm hazards come in many forms including surge, heavy rainfall, inland flooding, high winds, etc. Knowing your vulnerability and what actions you should take can reduce the effects of a hurricane disaster, and it is essential that you and your family are ready before a storm approaches.

On the next page is a list of documents included in the FISH Hurricane Preparedness Information Packet. If you have medical conditions that may require assistance, please read the Special Needs Shelter information and fill out the Special Needs application included in this packet.

Transportation to a special needs shelter is provided by the county if needed. If you have electrical medical equipment, it is highly recommended that you opt for the Special Needs Shelter which has a back-up generator. It is rare for any hotel to have electrical back up for public use.

Applications for the Special Needs Shelter will not be processed when Lee County is in the 5-day hurricane forecast cone, so please register as soon as possible. Our goal is to keep you and your family informed and safe in the event of a major storm. Please contact Erika Broyles at FISH at erika@fishofsancap.org 239-472-4775 with any questions or concerns.

Please note, FISH does NOT provide transportation during storm conditions. Those needing transportation must make advance arrangements with friends or family.

SPECIAL MEDICAL NEEDS PROGRAM Lee County Public Safety

The information on the following two pages will help you make the best possible decision for your safety and well-being in the event of an impending hurricane.

Our Special Medical Needs Program offers transportation and shelters for residents that do not have a safe place to be during the storm, or do not have a way to get to the shelter. If possible, arrange to evacuate with family, friends, or at a motel out of harm's way for your "Plan A". A shelter should be your 'Plan B".

Making specific preparations now for where you will go if a hurricane is heading this way will take the worry and stress off both you and your loved ones. Pack items to take with you well in advance so you will be ready to leave as soon as evacuation orders are issued.

Emergency Public Shelters are usually located in buildings with large open areas, such as schools, and are a good fit for anyone who is self-sufficient and needs no outside assistance in performing activities of daily living. You will be provided floor space only, so you must bring everything you need to shelter, such as bedroll, lawn chair, pillow, blanket, clothes, etc. Food and water will be provided but it would be wise to bring some of your own, as well. Shelters will be crowded, and with a large storm, may fill up quickly.

Special Medical Needs Shelters are located in schools, as well, and are for individuals whose medical issues cannot be managed in a public shelter. Electricity is provided for medical equipment. You need to have a companion/caregiver accompany and assist you during sheltering. We will provide oxygen at the shelter. You must bring your medical equipment, medicines, personal items, money, etc. Your companion/caregiver must bring the same things, plus something to sleep on, such as a cot or lawn chair. We plan to have cots for those registered, but in a catastrophic storm our supplies will run out, so bring the things you cannot do without. Your pet may shelter with you. You must bring crate/carrier, leash & collar, food, clean-up supplies, vaccination record, and any other comfort items for pets.

Shelter spaces in **Hospitals** are assigned to people whose health issues are unmanageable in a Special Medical Needs Shelter. Sheltering will be in hallways, meeting rooms, or other large congregate spaces, and no medical attention will be provided. You MUST have a companion/caregiver shelter with you the entire time. A letter from your physician must accompany the application. A bed will be provided, and oxygen, if required. You must bring your medical equipment, medicines, personal items, money, etc. Your caregiver will need to bring the same items, plus something to sleep on. You may NOT bring your pets to shelter at the hospital.

Transportation to shelters can be pre-arranged by completing this application. LeeTran provides transportation to the shelters and Lee County EMS to the hospitals for those requiring stretchers. If you do not pre-arrange shelter transportation and realize you have no way to get to the shelter, you can go to any of the LeeTran bus stops and get a free ride to the shelters.



Hurricane Evacuation Check List

Make Your Plan

- Plan A: If possible, arrange to evacuate to family/friends/motel outside any evacuation areas.
- Plan B: Submit your Special Medical Needs Application
- Complete the Family Emergency Plan and keep it in your Go-Kit
- Start preparing your Go-Kit with the things you can pack early
- Know Your Evacuation Zone
- Let your family/friends know your evacuation plan
- Download the LeeAlert app

Approaching Storm

- Contact family/friends where you are evacuating to confirm your plan
- Secure your home and shutters

Ordered to Evacuate

- Confirm the evacuation is for your area check the LeeAlert app, our website, or social media sites
- If you are registered with the Special Medical Needs Program, you will receive a call from us to confirm your shelter and transportation plans
- Finish packing your Go-Kit. Bring items critical to your survival, such as:
 - o Important documents (ID, insurance/medical cards, etc.)
 - o Prescriptions, over-the-counter pain and cold meds, etc.
 - o Cash from the bank to get you through a few weeks
 - o Medical support equipment (nebulizer, feeding pump, wheelchair, etc.)
 - ✓ Portable oxygen tanks to get you to the shelter, then home
 - ✓ Do **not** bring your concentrator
 - o Personal hygiene items, clothing, blanket, pillow, extra glasses
 - o Non-perishable food, can opener, snacks, drinks
 - o Radio, ear buds or headphones, flashlight, extra batteries
 - o Books, magazines, cards, puzzles, etc. to help pass the time
- Secure your valuables or take them with you
- Empty your refrigerator/freezer
- Turn off electrical power at main box
- Secure your home and evacuate area

Return Home

- Listen to radio/television for official announcement that it is safe to return to your area
- Determine that your home is not damaged and is "livable"
- Listen to the radio/television for information on FEMA or Small Business Association phone numbers for assistance

BASIC ADVICE FOR HURRICANE PREPARATION

- <u>Do Not Wait</u> until the last minute to prepare start ahead of Hurricane season (begins June 1st.) Put together organized containers or rolling carry-on suitcases of supplies, ready to grab in the event of an evacuation. Be sure to check expiration dates on foods and batteries.
- **2. Have a written copy** of all phone numbers of family, friends, neighbors, doctors, pharmacies, banks, etc. kept in a waterproof pouch or special waterproof container.
- **3. Shortly Before, During and After a storm**, ATMs and credit card machines may not be available, so before evacuating, be sure to have cash with you and to keep it secure.
- 4. **Know your employer's** Emergency Disaster Plan to ensure you know what is expected of you during an emergency, and if it may affect your Family Emergency Disaster Plan.
- 5. **Keep your car's gas tank filled** as a matter of habit so you don't have to rush out at the last minute and get stuck in long lines trying to get gas to evacuate the area.
- 6. **Renters**, know how to contact your landlord and have it written down. Know your responsibilities as a renter in securing belongings, your liabilities, and those for which your landlord is responsible. Know who is responsible for debris clean up both inside the rental and in the yard/common area.
- 7. Homeowners have a copy of all insurances (flood, wind, homeowners, health, auto, recreational vehicles, etc.) and your landscapers, pool service, cleaning service, etc. If you have a dock and/or boat, know your coverage and what to do in the event of an evacuation. Know your deductible and who is responsible if a neighbor's tree falls on your property. Know who to contact to help with yard debris and interior damage. Have tarps in case of roof damage you may not be able to find tarps after a storm.
- 8. The City of Sanibel has a list of licensed contractors. <u>NEVER give cash in advance to anyone who comes by and offers to help.</u> Use only City of Sanibel approved <u>licensed contractors</u>. Be sure to have a copy of the city's list in advance. If you have a local contractor with whom you have worked, you may want to call or email them to get on a list, in advance of possible evacuation, for post storm work you may require.
- 9. Wind Driven Rain Damage even shuttered windows and storm windows or sliding doors may be vulnerable to wind-driven rain that could damage the interior of your home. Know if you are covered by your insurance or if you must pay out-of-pocket.
- 10. Condo Owners know your association's responsibilities and those for which you are liable in the event of an evacuation and possible damage to your unit, both interior and exterior. Ask about unit owners' insurance if you do not have it.
- 11. Photos and Videos of all belongings both inside and outside your home are invaluable for insurance purposes. Keep your photos updated. Bring the photo/video records with you in an evacuation in a waterproof pouch or container. After a storm, document all damage to your property, both outside and interior as soon as possible a written list, photos and/or video. These before and after photos/videos can then be compared for your insurance claims.
- **12. After the storm,** keep a list of estimates for repairs from each contractor you may need to use, from roofers to carpenters to landscapers. Know exactly what is covered, what is not, what is completed, what still needs to be completed.

FISH WILL BE OPEN AFTER A STORM AS SOON AS SAFELY POSSIBLE. Our 24-hour phone line (472-0404) will be open – unless the call center has been damaged by a storm. **FEMA APPLICATIONS** – help will be available to get your application completed.

<u>Be Advised:</u> These shelters will <u>NOT</u> all be open during any single event. The opening of shelters is dependent upon the nature of each specific event.

- CHECK TO SEE IF YOUR SHELTER IS OPEN BEFORE GOING. <u>NOT ALL WILL</u> <u>OPEN, NOR AT THE SAME TIME</u>.
- Weapons, smoking, and alcoholic beverages are prohibited at all shelters.

PLEASE NOTE: Pet-friendly sheltering will be available in the shelters. Announcements will be made at the time. *Check the web site* and local news reports often. Be sure to read the pet information included in this

Hurricane Information Packet so your pet(s) requirements and needs are met, and you know what your responsibilities will be.

<u>KNOW YOUR EVACUATION ZONE</u> - *Visit the website*: <u>www.LeeEOC.com</u> to learn your zone.

- Click on "Know My Evacuation Zone" in the navigation bar
- 2. Click on "Find My Evacuation Zone" link
- 3. Enter your address in the search bar (SANIBEL IS "A" ZONE among the first zones to be evacuated).
- 4. If evacuating to a friend or relative's home, be sure they are <u>outside of both A & B zones</u>. If the storm is very severe, you may also need to leave a B zone area due to the dangers of flooding by tidal surge.



PET-FRIENDLY & SERVICE ANIMALS - SHELTER INFORMATION

In a hurricane, pets are subject to the same hazards as people and have many of the same needs. The best plan is to identify a safe location that allows pets outside the areas, such as a friend or family member's home or a pet friendly hotel. Find a suitable hotel outside the evacuation area (www.pethotelsofamerica.com). Lee County will have Pet-Friendly Shelters. Your pets will be in one area away from the people sheltering in every evacuation event. <a href="The locations and number may vary; check the local news and the website often to see where open shelters will be located and which ones will allow pets. Shelters will take dogs and cats only accompanied by owner.

- Lee County Animal Services (<u>www.leelostpets.com</u>) manages this shelter. (239) 533-7387
- · All Pet-Friendly Shelters are first come/first served. No pre-registration is allowed.
- Use of these shelters is restricted to persons living in an area that is under evacuation.
- You must shelter at the facility with your pet (in other words, you cannot drop your pet at the facility and shelter elsewhere). The pets will be sheltered in a separate location at the facility and cannot stay by you. Owners will be responsible for feeding, exercising, and cleaning up after their pets at scheduled times.
- ❖ Service Animals Only may stay with an owner in either a public shelter or a Special Care Shelter.
- ❖ Pets and Comfort Animals are NOT permitted to be with you at the Special Care Shelters and are permitted only at the regular Shelters. Questions regarding your animal at a Special Care Shelter should be directed to: Tiffany Grant 239-533-0640

Your Pets, Service Animal or Comfort Animal will need a Hurricane Disaster Kit, too. Include:

- Lee County License and other Identification (Talk to your vet about microchip identification)
- Have **good photos** of your pet in case you get separated.
- All vaccinations must be up-to-date. Have a copy of the records with you. Rabies certificate from your vet is a MUST.
- Water for several days one gallon per day for seven days for each animal and a bowl
- Non-perishable food for several days, including treats and a feeding dish
- A collar and leash for each pet. Be sure identification tags are on the collars.
- Your pet's prescriptions and medications to keep your pets healthy, clean and free of parasites
- Clean-up supplies (litter box. Litter, scoop for cats) (plastic bags) to keep your pets healthy, clean and free of parasites
- Sturdy, Impact Resistant Cage or Carrier for each animal to comfortably hold your pet (no soft carriers or make-shift containers)
- Bring toys, chew toys and comfort items for stress relief; bring bedding as well.

REMEMBER:

- Never leave your pets outside during a storm.
- **Never** leave a cat with a dog, even if the two are normally friends.
- Dangerous animals should be secured in special crates or cages.
- Any unsecured animals posing a danger will be at risk of being destroyed.

<u>PLEASE NOTE:</u> All animal facilities in the path of a hurricane are subject to some degree of damage or flooding. Keep in mind, boarding kennels and animal hospitals may be without electricity or potable water and have limited personnel and supplies for days to weeks following a disaster. <u>Call Lee County Animal Services at (239) 533-7387 for more information on Pet Friendly Shelters.</u>



List of Fort Myers Area Hotels & Motels 2024

This is not a comprehensive listing of area accommodations, but only those that are more inland from affected evacuation zone areas. (*Please see full color evacuation zone map enclosed in this packet.*) The closer to I-75 and beyond, the safer it is. **If possible, it is recommended that you shelter at a Lee County Shelter.**

PLEASE NOTE:

- 1. Many will be calling to shelter at a hotel. <u>Have a back-up plan for shelter in case you cannot reserve a hotel</u>. CALL THE HOTEL DIRECTLY AT THEIR LOCAL NUMBER, not the toll-free number or through a booking agency. The local staff will know the storm situation and be able to respond to your questions accurately. Give the hotel your <u>home and cell phone numbers</u> to ensure the hotel can contact you if there are changes to your reservation.
- 2. ASK IF YOU COULD BE REQUIRED TO LEAVE THE HOTEL FOR OTHER SHELTER AT ANY POINT DURING OR AFTER A STORM. Even with a reservation of several days, hotels are not required to be shelters and each has its own policies regarding sheltering during and after a storm, especially as electrical outages, or other issues, such as sanitation, arise.
- 3. Electric Many hotel elevators will not be operational during a storm for safety purposes, whether the electricity is on or not. If you have mobility issues, request a ground floor room.
- 4. <u>Very few hotels have back-up generators</u>, and some are for office space only. <u>Double check with the hotel regarding their generator specifically for guest rooms before you reserve.</u>
- 5. If your health requires you to have air conditioning, if your medications need refrigeration, or if you have medical equipment requiring electricity, it is highly recommended you fill out the Special Needs Application and go to the Special Needs shelter where a back-up generator is guaranteed. Transportation is provided to the shelter, but you must be pre-registered well in advance. (See enclosed brochure.) Special Needs stops taking applications when a storm is 5 days away.
- 6. Bring your own lanterns or flashlights and plenty of extra batteries (be sure they are fresh). Keep your CELL PHONE charged if there is electrical power. Bring an extra charged battery or two when possible.
- 7. Hotel food services may be interrupted or completely discontinued prior to, during or after the storm hits. You will need to bring your own supplies of NON-PERISHABLE foods and drinks for several days and personal items. Supplies are not delivered to hotels during a storm.
- 8. <u>PETS</u> Most hotels require the pet to be on a leash and/or to have a crate or may restrict the type or size of pet. ASK if a pet fee is required since some waive the fee and/or pet restriction in a storm event. Hotels must always accept Service Animals but are not required to accept pets even during an evacuation. Any hotel may choose whether to take pets during emergencies such as an evacuation. Be sure to ask the hotel about pets, including comfort/therapy/companion animals which are not considered service animals. You will not be



- able to take your pet outside during a storm. Be prepared to clean up after your pet indoors. Be honest about the breed, type, and number of pets. (Bring cat litter, pet pads and disposable bags to meet your pet's needs for several days.)
- 9. DO NOT CALL FISH FOR A RIDE DURING A HURRICANE EVACUATION. FISH volunteers do <u>NOT</u> transport during evacuations. Call Island Taxi at (239) 472-4160.
- 10. Whether you choose to go to a hotel or a shelter, have all your prescriptions filled and other necessary medications or medical supplies with you in original bottles/containers, and any other personal supplies you may need. Storms are unpredictable and your stay may become longer than anticipated. Be prepared. Review the checklist included in this packet and add to the list other items you may need to make sure you have everything for your evacuation and possible extended stay.
- 11. Once all your questions are answered and you have made a reservation, <u>print out your confirmation to show the front desk in case computer access is interrupted</u>.

ADDITIONAL MEDIA SOURCES OF INFORMATION

IPAWS – Integrated Public Alert & Warning System is a FEMA mass notification system that reaches multiple dissemination systems such as the Emergency Alert System (EAS) – the system that hits TV and radio – and the Wireless Emergency Alerts (WEA) which hits all mobile devices within the region of selected cell phone towers. It is used to alert county residents of an approaching storm and evacuation notices as well as other public safety emergencies.

AlertLee — The AlertLee system enhances officials' ability to quickly communicate with the public and provide critical and time-sensitive information for emergencies such as hurricanes, wildfires, evacuations and missing persons. By registering for AlertLee, you can receive alerts via cell phone by voice or text, email addresses, home phone, business phone and more. Go to alertlee.com or through mysanibel.com to sign up for alerts. When you register for the AlertLee System, you will be given the opportunity to register for Sanibel specific alerts issued by Lee County Emergency Managers. For more information visit AlertLee frequently asked questions.

LeeEvac is a Mobile App that can be used to find your evacuation zone (Sanibel is Zone A) for Lee County. Use your current GPS location, tap on the map, or search for an address within Lee County to see if you are in an active evacuation zone, at any time. If an evacuation is ordered for your area, instructions on how to find additional information will be provided. This app is provided by Lee County Government.

These items are recommended to have in an emergency supply kit. Modify this list to meet your needs. Plan to have enough supplies on hand to get you through a minimum of three (3) days without power or possibly longer.

Have a plan in place in case you cannot return to your home due to storm damage. PACK MOST OF YOUR SUPPLIES IN ADVANCE SO YOU ARE READY TO GO AT ANY TIME

PERSONAL ITEMS

Medications for at least 2 weeks - 1 month

- (Prescription and Over-the-Counter Pain and Cold Medications – BE SURE TO REFILL EARLY)
- Spare Eyeglasses or Contacts and Cleaning Solution / / Eyeglass Repair Kit
- Hearing Aids (spare batteries)
- Cell Phone & charger adapter; extra batteries
- Coins, Cash, Credit Cards (Credit cards/ATMs will not work if electric is off)
- Spare Keys (complete set for home, vehicles, and boats)
- Residential Hurricane Pass (Green)
- Important Documents (ID, insurance, medical, emergency contact persons, COVID Proof of Vaccination.)

- Raingear Raincoat, Umbrella, Boots, etc.
- Sleeping Bags and/or Pillows, Sheets, Blankets
- Lawn Chairs / Folding Chairs

FOOD SERVICE NEEDS

- Drinking Water (one gallon per day per person for a minimum of 3-7 days)
- Disposable Plates, Cups and Plastic Cutlery, Roll or two of Paper Towels
- Plastic Wrap / Zip Lock Bags / Garbage Bags

MISCELLANEOUS

- Maps and Evacuation Information
- Pens / Pencils and Paper, sharpener
- Keepsakes / Significant Photos
- Prepaid Telephone Card(s)
- Books, Puzzles, Deck of Cards, Games, MP3 player/batteries/headset, Coloring Books, Coloring Pencils, Other Quiet Entertainment

BASIC SAFETY EQUIPMENT

- NOAA Weather Radio
- First Aid Kit with Bandages & Instruction Book
- Battery Powered Television, Radio and Clock – bring extra batteries
- Flashlights or Lanterns (extra batteries)
- Chemical Light Sticks (to replace candles)
- Whistle (to signal for help if needed)
- "CAR KIT" include Flares, tire patch or "fixa-flat", blankets, shovel, jumper cables, tow rope
- Tool Kit



EMERGENCY SUPPLIES CHECKLIST

OTHER ITEMS I WILL NEED

- Medical Support Equipment wheelchair, cane or walker, etc.
- Oxygen provided at Special Needs Shelter, but you will need 2 oxygen tanks: 1 for traveling to the shelter, 1 for returning home. NO Concentrators permitted at the SN Shelter.
- Bug Repellent
- Sun Screen for after storm yard clean up
- Printed List of important and emergency contact phone numbers (family, doctors, etc.)

FOR CLEAN UP DAYS

- BLEACH (without lemon or additives) 1 drop per 1 pint (8 per Gal.) of water for cleaning
- Matches in waterproof container
- Bottle or two of Hydrogen Peroxide (50% mix with water = disinfectant)
- Work Gloves, heavy closed-toe shoes, long pants, long sleeve shirt, hat and boots

Flood Zones

What Are Flood Zones?

Flood zones determine the premium for flood insurance rates and set construction standards for parcels located in the Special Flood Hazard Area (SFHA), commonly called the FEMA floodplain.

The SFHA is an area that could be inundated by a flood event, with a 1 percent chance of reaching or exceeding the Base Flood Elevations (BFE) in any given year. This is also called the 100-year flood.

Flood zones in the Special Flood Hazard Area begin with V or A. Most mortgage lenders require flood insurance in these zones. Insurance rates are calculated using the Base Flood Elevation (BFE).

Find My Flood Zone

Here is an easy tool to quickly find your Flood Insurance information. Click Find My Flood Zone. When the map opens, click the magnifying glass in the upper right corner and enter your address. The map will zoom to the location and a dialog box will open with your property information. You can also open the Flood Report and the Property Report.

Flood Zone Explanations

Special Flood Hazard Areas (SFHA) - The land area that could be covered by the floodwaters of the base flood is where the NFIP's floodplain management regulations must be enforced and where the mandatory purchase of flood insurance applies for federally backed mortgages.

Zone	Explanation
А	Areas subject to inundation by the 1-percent-annual-chance flood event generally determined using approximate methodologies. Because detailed hydraulic analyses have not been performed, no Base Flood Elevations (BFEs) or flood depths are shown. Mandatory flood insurance purchase requirements and floodplain management standards apply. (In unincorporated Lee County, the county has estimated BFEs in these areas.)
AE, A1-30	Areas subject to inundation by the 1-percent-annual chance-flood event determined by detailed methods. Base Flood Elevations (BFEs) are shown. Mandatory flood insurance purchase requirements and floodplain management standards apply.
АН	Areas subject to inundation by 1-percent-annual-chance shallow flooding (usually areas of ponding) where average depths are between one and three feet. Base Flood Elevations (BFEs) derived from detailed hydraulic analyses are shown in this zone. Mandatory flood insurance purchase requirements and floodplain management standards apply.
АО	Areas subject to inundation by 1-percent-annual-chance shallow flooding (usually sheet flow on sloping terrain) where average depths are between one and three feet. Average flood depths derived from detailed hydraulic analyses are shown in

Some Zone AO areas have been designated in areas with high flood velocities such as alluvial fans and washes. Communities are encouraged to adopt more restrictive requirements for these areas.
AR	Areas that result from the decertification of a previously accredited flood protection system that is determined to be in the process of being restored to provide base flood protection. Mandatory flood insurance purchase requirements and floodplain management standards apply.
А99	Areas subject to inundation by the 1-percent-annual-chance flood event, but which will ultimately be protected upon completion of an under-construction Federal flood protection system. These are areas of special flood hazard where enough progress has been made on the construction of a protection system, such as dikes, dams, and levees, to consider it complete for insurance rating purposes. Zone A99 may only be used when the flood protection system has reached specified statutory progress toward completion. No Base Flood Elevations (BFEs) or depths are shown. Mandatory flood insurance purchase requirements and floodplain management standards apply.
V	Areas along coasts subject to inundation by the 1-percent-annual-chance flood event with additional hazards associated with storm-induced waves. Because detailed hydraulic analyses have not been performed, no Base Flood Elevations (BFEs) or flood depths are shown. Mandatory flood insurance purchase requirements and floodplain management standards apply.
VE, V1-30	Areas subject to inundation by the 1-percent-annual-chance flood event with additional hazards due to storm-induced velocity wave action. Base Flood Elevations (BFEs) derived from detailed hydraulic analyses are shown. Mandatory flood insurance purchase requirements and floodplain management standards apply.

Zones outside the SFHA (floodplain) - Moderate flood hazard areas, labeled Zone B or Zone X (shaded) are also shown on the FIRM but are not considered part of the Special Flood Hazard Area.

	X (shaded), B	An area of moderate flood hazard that is determined to be outside the Special Flood Hazard Area between the limits of the base flood and the 0.2-percent-annual-chance (or 500-year) flood.	
(C	X (unshaded),	An area of minimal flood hazard that is determined to be outside the Special Flood Hazard Area and higher than the elevation of the 0.2-percent-annual-chance (or 500-year) flood.
